The Adventure Golf course hours of operation are: HOURS: 8:00 a.m. – 11:00 p.m. Unless rented for a private party or event

- 1. Children under the age of 13 MUST be accompanied by an adult when playing on the Adventure Golf course.
- 2. Running and jumping on the equipment is not allowed.
- 3. No glass containers allowed.
- 4. Players must follow the course rules posted at the Adventure Golf Course.
- 5. Anyone not following these rules will be asked to leave the Adventure Golf course.
