- I. The meeting was called to order at approximately 6:11 pm by President Raymond Escoto.
- II. The Invocation & Pledges were led by Swen Crone.
- III. President Escoto asked for approval of the April 10<sup>th</sup>, 2025, Agenda. A Motion was made by Tiffani McKinney and seconded by Doug Johnson. Tiffani McKinney asked for the agenda to be amended and that approval for two new bank accounts be added to New Business. One account designated for the \$6 assessment related to the golf course irrigation and a seconded \$200,000 cash reserve as part of the financing package for golf irrigation. The motion was restated to include banking with new business on the agenda by Bill Williamson, 2<sup>nd</sup> by Doug Johnson, unanimously approved.
- IV. Approval of March 15<sup>th</sup>, 2025, Minutes motion made by Tiffani McKinney, 2<sup>nd</sup> by Kyle Beale, unanimously approved.

e. Lakes & Dam Committee / Mr. Mike McMullen will be resigning as the Chair of the Committee this month- The POA Board will be taking care of the Dam section of the committee, and Mr. Knight and Mr. Kline will serve as Co-Chairs for the Lake Committee

IX. Members to be heard – April 10<sup>th</sup>, 2025, Agenda Topics-

- a. Randy Patro spoke regarding the golf course- he stated he probably should have asked these questions a couple of months ago- in reference to the irrigation system how is this going to help the fringes, is there a plan in place? Mr. Patro would like to know if the relief valves that were dismantled or bypassed will be used on the new system. Mr. Escoto said he would have an update on that at the next meeting. Mr. Patro asked about being able to reuse our current sprinkler heads, Mr. Escoto stated yes, they are interchangeable, our current system has never been replaced, and it needs replacement. Mr. Patro asked about going from 2 pumps down to 1 pump. Mrs. McKinney stated that yes, we would be going to 1 new pump, and that is all that will be needed with the new system, all parts will be under warranty. Mr. Patro would like to take this time to thank The Golf Course Supt. Bryan Pace for everything he has done, he has turned the course around and has it looking very nice.

X. Old Business

- a. Golf Course Irrigation – Discussion Only- the 84<sup>month</sup> Terms and Conditions of the loan were signed today. Monthly payments of \$20,891 will be made for the irrigation system. We are hoping to see movement on this project within 30-45 days. During this project the golf course will not be closed.
- b. Kickapoo Club – Discussion Only the Kickapoo is at 98% structurally complete. The bar top will be delivered on Tuesday. Mrs. Ann Falconer and her group will handle all the décor. A property Owner asked if those in attendance could look at the progress and Mr. Escoto said absolutely.

XI. New Business

- a. Bill Williamson made a motion to Approve CERT to use all facilities during emergency situations – Doug Johnson 2<sup>nd</sup> the motion, unanimously approved.
- b. Board Approval – Takeback Lots – Discussion & Action- Doug Johnson made a motion to approve the takeback lots that were discussed and Kyle Beale 2<sup>nd</sup> the motion. Tiffani McKinney discussed with the board the two lots that currently had minor issues be cleared up prior to taking them back. The board agreed to take them back once issues were resolved. The motion was restated to include resolving issues. Unanimously approved.
- c. Tiffani McKinney made a motion to set up an account with Texas Capital as a reserve for the Golf Irrigation System Doug Johnson 2<sup>nd</sup> the motion. Unanimously approved.

d. Tiffani Mckinney made a motion to set up an account with Texas Capital designated for the Golf Irrigation System funds Doug Johnson 2<sup>nd</sup> the motion. Unanimously approved.

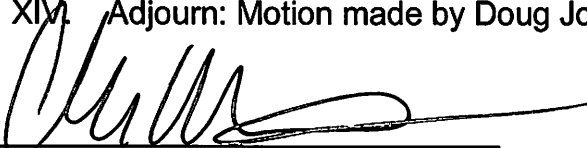
XII. Members to be Heard – Other Topics

He is wondering how much the Airport is charging to use the taxiway; are they required to pay a fee and obtain a sticker. He would also like to know about the boat launch fees, and bridle path fees for horse owners- Mr. Escoto asked what the direct question is, Mr. Patro said he would like to know why there is such a wide range of fees. Mr. Biff Adams responded to the question stating that the golf course is our "Crown Jewel" and is also our largest expense, he stated that Hilltop Lakes Trail Fee is the cheapest fee around.

b. Randy Schiamara is requesting the board to remove the speed bumps.
